9th May 2024 Launch of Air Quality Standard

As a stakeholder, Greenwatch was invited to the official launch of the National Environment (Air Quality Standards) Regulations of 2024 by the National Environment Management Authority (NEMA). This marks an important step in Uganda's efforts to combat air pollution and protect public health. The regulations, developed through extensive collaboration with key stakeholders, including the U.S. Embassy and Kampala Capital City Authority, set clear standards for indoor air quality in workplaces and enclosed environments.

These regulations impose emission limits on industrial facilities, vehicles, and other pollution sources, backed by a robust permit and compliance program. Industries that exceed emission standards will face severe penalties, including fines and imprisonment. Local governments will play a critical role in enforcing these regulations, as emphasized by Jennifer Kutesakwe. Senior **Environment** Inspector in charge of air quality.

20th May 2024 - Sixth Judicial Training on Enforcing Environmental Laws



In partnership with the Judicial Training Institute, Greenwatch hosted its sixth annual judicial training on climate justice in Mbale, Eastern Uganda. Themed "Enforcing Environmental Laws in the Age of Climate Crisis," the event emphasized the judiciary's crucial role in addressing climate change and enforcing environmental laws. Hon. Justice Godfrey Namundi the Resident Judge of Mbale highlighted the importance of equitable decision-making and holding polluters accountable, especially in light of recent environmental disasters like the floods in Mbale.

The training featured in-depth presentations on environmental law and climate change, focusing on practical skills in adjudicating climate related disputes. Legal Advocacy



Greenwatch's Court Battle Over Forest Cover Loss

Greenwatch continues its legal battle against the Ugandan government for failing to curb the alarming loss of forest cover. The case, filed in January 2021, asserts that government entities have neglected their duty to protect Uganda's forests, resulting in a violation of the constitutional right to a clean and healthy environment. The next hearing date is set for 12th November, 2024, with the inclusion of an Amicus Curiae from the National Association of Professional Environmentalists (NAPE)

Greenwatch Empowers Young Lawyers on Climate Action, Litigation, and Justice





On August 15, 2024, Greenwatch, in partnership with the Uganda Law Society (ULS), hosted a training session for young lawyers. The event, themed "Igniting Passion for Climate Justice," aimed to prepare the next generation of legal professionals to tackle climate change through strategic legal action. The training emphasized the urgent need for legal professionals to advocate for stronger environmental protections, particularly in the wake environmental disasters like the recent Kiteezi Landslide. The training provided young lawyers with practical tools and strategies to advance climate justice in Uganda and beyond.
