An amicus curie application was filed by the National Association of Professional Environmentalists(NAPE) and the court has since set 25th June 2024 as thenew date for the hearing of the amicus application. **⇒** Civil Suit No.283 of 2012, Nissi Mbabazi VA.G & 2 Ors In 2012, four (4) minors and Greenwatch filed a lawsuit against the Attorney General and the National Environment Management Authority in the High Court of Uganda. The complaint invokes the government's public trust duty under Articles 39 and 237 of the Uganda Constitution to protect the country's atmospheric resources from

climate change for the benefit of current and future generations. The lawsuit asks the

defendants to develop a climate change mitigation plan per the best science and

protect children from the adverse impacts of climate change. Parties have filed the

witness statements and the court has set the 13th of May 2024 as the date to hear

## the evidence.

**→** Networking and Civil Society engagements

During the last half of 2023, Greenwatch has been vigorously involved in networking with government, and sister Civil Society Organisations to scale up collaboration and harness our efforts for environmental action and resilience. On 4th August 2023, Greenwatch represented by Ms. Ampurira Bridget attended the Women in Nature Conservation WiNN is a network of women across the world who are working to conserve natural ecosystems and species to strengthen the role of women in conservation leadership and enhance conservation impact.
